<b>Denver Bailey, MPH</b> Epidemiologist Durham County Dept. of Public Health	<p>Denver will give a brief presentation at every meeting on opioid overdoses. Naloxone reversals by Durham EMS is a more accurate indicator of the number of overdoses seen in Durham County. There have been 326 reversals have occurred in 2016, with 106 between January and March. EMS reserves median age is 50, predominately male. Emergency department data is undercounted due to the way it is reported.</p> <p>Denver will share EMS naloxone reversal given by location in Durham next month. She will also explore other sources of data.</p> <p>People are working to resolve the data issue at Duke about what is downloaded into the records and what is tracked.</p>	<p>It may be interesting to track how many doses are given to each patient.</p> <p>Talk with Duke VP of ED, Jessica Melton to discuss what data is needed.</p>	Denver will follow up with Kim to set up a meeting with Jessica Melton and DCoDPH staff.

Several providers requested materials to become more LGBTQ competent. Next steps include analyzing the responses, responding to the providers request with additional materials or training or hold a more formal presentation or training in 2017 for interested providers.</p> <p><b>Resources-</b> The workgroup discussed the Duke resources manual. The resources list should be no more than one to four pages referring people to the Network of Care website. Next steps are to:</p> <ul style="list-style-type: none"> <li>• Follow up with Michelle Burgess and review Network of Care website to see what's missing.</li> <li>• Collect resources to send to Marissa to list on Partnership website.</li> <li>• Each review a few pages in the resources binder to update and streamline.</li> <li>• Develop a guide tailored to providers so they know where to refer patients for substance use/mental health needs. Something more general is needed for individuals. Keep it simple, short form on paper and long form on Network of Care.</li> </ul> <p><b>Faith-based-</b> Monument of Faith church was interested in substance use/mental health information. Several committee members attended or provided information and the event was well attended. Extra resources from that event were used at the October event at Victorious Life Fellowship Church. organizations. Next steps include:</p> <ul style="list-style-type: none"> <li>• Kim will contact six churches on the list of 16 previously contacted to follow up.</li> <li>• Send information through Durham Congregations in Action and IMA.</li> <li>• Add substance use/mental health resources to clergy orientation done by Duke Office of Community Resources.</li> <li>• Find out what type of training pastors would like/need and what do congregations need.</li> </ul> <p><b>Naloxone-</b> Through partnering with Duke Northern Piedmont Community Care (NPCC), Cindy blast faxed 117 pharmacies about the naloxone standing order, Medicaid information and Cindy's contact information.
