NCCare360 is a uniform online referral system available statewide to connect providers, patients and organizations. NCCare360 is the first statewide coordinated network that includes a robust data repository of shared resources and connected healthcare. Partners include Foundations for Health Leadership and Innovation (FHLI), Unite Us, Expound, NC Department of Health and Human Services (DHHS), United Way 2-1-1. Wake and Johnston Counties plan to launch NCCare360 by the end of April with more than 100 organizations. The goal is to launch in Durham this year.

NCCare360 has configurable screening- patient and/or provider facing algorithmic screenings to stratify risk and identify specific co-occuring needs. The tool also has electronic referral management, assessment/care plan management, bi-directional communication/alerts and knows what services were delivered and the history for every intervention with external partners. The tool asks about needs such as child care, housing and transportation to make sure needs are being met.

The next steps include a follow-up meeting on how this will work at the County level, strategy sessions for community organizations on how it would work for them, workflow planning with organizations, complete partner registration form and software training and then the launch. This process takes about 90 days, which will start in May and end with a launch in August.

There was a Q&A following the panel. The main points from the discussion were:

- NCCare360 will have the ability to send referrals for certain populations such as immigrants, refugees, domestic violence victims but there needs to be a level of trust between these organizations
- Georgina Dukes worked with the Access to Care committee Durham Knows workgroup about how to adapt the software for people living with HIV to ensure confidentiality
- Plans for keeping resources updated- organizations agree to update information at least on an annual basis, reminders will go out to member organizations
- UniteUs has combined with EPIC electronic medical records (EMR) at ConeHealth, NCCare360 is having conversations with Duke, EMR integration is a possibility
- FHLI will pay fees for NCCare360 licensing, long-term plan is that community-based organizations (CBOs) would never pay a fee to use, individuals and organizations call United Way 2-1-1 as well
- NCCare360 is not just a Medicaid platform, for anyone to use, there will be an option to get on the NCCare360 website and do a self-assessment to find referrals on your own
- Community member needs to give informed consent to send referral on their behalf and can rescind consent at any time, special permissions built in on who can view which information, everyone won't be able to see all the information for a client
- Other communities have used data to advocate for where funds should be allocated with community benefit dollars
- NC DHHS has created nine screening questions for social determinants of health, NCCare360 will have additional questions to use
- The platform is not designed or consent given by patients to use data for research purposes, would have to look at how to do this
