An uptick in Latinx cases began in late April. DCoDPH started strategizing with partners to address COVID disparities in the Latinx community. Latinx cases in July represent 50% of all cases, but 14% of the Durham County population. In May/early June, Latinx made 78% of all cases. Credit for the numbers decreasing in the Latinx communities goes to DCoDPH partners.

DCoDPH staff combed through medical records for race and ethnicity data. Once Durham County crossed the threshold of 500 cases, the decision was made to share data publicly.

Durham County continues to work with that State on response and follow Centers for Disease Control and Prevention (CDC) and North Carolina Department of Health and Human Services (NC DHHS) guidelines. Rod stated that a county of more than 300,000 with less than 1000 deaths is remarkable. This is due to partnerships and work with elected officials. DCoDPH is working with businesses to enforce the latest stay at home in order to be able to reopen successfully.

COVID-19 is serious. Our response and behaviors are the only things we have to protect our families. Rod stated he is concerned about children. On July 14, Governor Cooper recommended a hybrid in-person and online activities for the school year. If people are not doing the 3 Ws (wearing a mask, frequent hand washing and waiting 6 feet apart) when in public and being public health champions, we can't expect things to change. We have to make sure we're modeling those behaviors right now.

Durham County COVID data is published on the data hub at <a href="https://durhampublichealth-durhamnc.hub.arcgis.com/">https://durhampublichealth-durhamnc.hub.arcgis.com/</a>. Tara Blackley shared the features of the data hub which includes information on demographics of cases, occupations, industries most impacted, weekly data reflections, data infographics, sources of infection by zip code and where to find Durham testing sites. The data hub also tracks stay at home percentages over time. DCoDPH is using data to make decisions about COVID interventions.

CHA Updates  Marissa Mortiboy,  Durham County  Department of  Public Health	The age of cases has been trending downward. DCoDPH recently changed how reporting race and ethnicity data. They are trying to combine race and ethnicity to be more accurate. In March, most cases were due to travel and medical professionals. In April, cases were focused in congregant living facilities and Butner prison. Cases began increasing in the Latinx community in May. Weekly data reflections and infographics that explain the data are updated on Fridays.  Rod and Tara answered audience questions. Housing, food security, travel for work and living in multigenerational housing are issues. Following up on cases and contact tracing are the focus of most DCoDPH COVID efforts. The health department uses data to drive decisions on where to concentrate efforts. DCoDPH will add mobile testing sites as they become available to the data hub.
