	There are currently 154 total active cases. There are 24,308 inactive cases. As of April	
	21, 222 have died from COVID in Durham County. There have been 24,689 cases since	
	the pandemic began in March 2020. The 7DMA is 48 as of April 19. This is a decrease	
	from 51 last week and an increase from 45 the previous week. There are 911 COVID-	
	19 cases so far in the month of April as of April 19.	
	During the month of April, Hispanic or Latinx individuals are proportionally	
	represented at 14% of cases. African Americans are overrepresented at 56% of cases	

and the White population is underrepresented at 24% of cases. Durham County positive rates are under 5% at 4.4% for the week of April 11.

As of April 20, 103,619 Durham residents have been fully vaccinated. This is 32.2% of the population. North Carolina Department of Health and Human Services (NC DHHS) shows that at least one dose has been administered to more than 124,421 in Durham County. Fully vaccinated percentage is at 30.3% and 38.7% have at least one dose in Durham County.

Everyone 16 and older is eligible for vaccination. There was a 4% vaccine increase during the month of April to date. Durham County residents have been vaccinated at 479 vaccination provider sites in the state. Of the white population in Durham County, 49% of residents have been partially vaccinated and 44% fully. Of the total Black or African American population, 26% have been partially vaccinated and 22% fully. For the Asian population, 47% have been partially vaccinated and 41% fully vaccinated.

Rod recognized LATIN-19 and Viviana Martinez-Bianchi and partners who have been doing great work to get the Latinx community vaccinated. DCoDPH is working with Siembra NC, La Semilla, El Centro Hispano and Ministerial Alliance. DCoDPH and partners submitted the Office of Minority Health grant for COVID-19 for Health Literacy grant with partner NCCU, Duke, CHWs and others. DCoDPH is currently working with Durham County EMS and internal data team to do geomapping to promote equity in vaccine distribution and identify areas with inequities and less vaccine uptake.

The Advisory Committee of Immunization Practices will meet on April 23, 2021 to decide about the Johnson and Johnson (J&J) vaccine.- https://www.cdc.gov/vaccines/acip/index.html. DCoDPH has paused administering the J&J vaccine due to blood clotting concerns and is waiting for the ACIP decision.

	Rod will be reaching out to AACT+ in regards to uptick in African American COVID-19 cases. At this time, strategies are moving towards doing community vaccine events in the community including partnering with UNC Mobile to distribute vaccines.	
Medicaid Transformation Michael Leighs, North Carolina Department of Health and Human Services Debra Farrington, North Carolina Department of Health and Human Services	This change to Medicaid is the biggest in Medicaid's 50-year history. NC legislature mandated about 5 years ago to move to managed care instead of fee-for-service. Some managed care is happening for those with behavioral health needs, but not everyone in the program. NC DHHS is excited about the opportunity to drive non-medical drivers of health. NC DHHS is in the middle of procuring Healthy Opportunity pilots to address social determinants such as food, housing and transportation. Managed care means health plans will be available to assist individuals. That plan will assign care managers to individuals. There will be multiple types of health plans. Key features of transformation include whole-person focus and Healthy Opportunities Initiative. Integrated physical and behavioral health and payment and delivery integration. Anticipate awarding Healthy Opportunities in spring 2021 and service delivery in early 2022. Primary care and local care management investment with advanced medical home program and behavioral health home and care management.	
	Medicaid covers about 2.5 million in NC. About 1.6 million of those will transition to managed care. There are five state-wide- WellCare, UnitedHealthcare, HealthyBlue, AmeriHealth Caritas and Carolina Complete Health. There will be a first in the nation Eastern Band of Cherokee Indians Tribal Option along with other plans on July 1, 2021. NC Medicaid Direct and Tailored Plans for Behavioral Health I/DD Tailored Plans will start in July 2022. The plans will offer the same services as other plans with more specialized services for Behavioral Health I/DD populations. Most Medicaid beneficiaries will enroll in NC Medicaid Managed Care. The timeline for open enrollment is March-May 2021. Reminder postcards went out	
	April 15, 2021. Automatic enrollment will take place for beneficiaries on May 15, 2021 if a plan is not selected. Beneficiaries will have 90 days after auto enrollment to	

change plan. Keeping current physician is one of the keys for selecting automatic plan. There is a six-step algorithm to help assign beneficiaries to a plan. There is also an equitable health plan distribution to make sure people are equally divided among plans.
